The Maryland Association of Boards of Education Distinguished School Board Service Award was established to honor MABE's first full-time executive director, Charles W. Willis. It may be presented every other year (alternating with the Maryland Association of Boards of Education Excellence in Education Award) to an individual selected by his or her peers to recognize distinguished board service at the state and local level.

Please note:

- Local school boards may nominate a current or former member of their own board, or a former or current member of any other MABE member board.
- Nominations must be made on behalf a majority of the board; individuals may not make nominations.
- A board may nominate only ONE candidate in a single year.
- Candidates from previous years may be re-nominated.
- Previous recipients of the award (formerly named the Charles W. Willis Memorial Award) are ineligible.
- Nominations that exceed the word limit will not be considered.
- Nominations, consisting of the submission form and the written Part I and Part II, received after the deadline will not be considered.
- All nominations are strictly confidential. Only the name of the recipient chosen by the committee will be announced.

Please submit your **complete written** nomination to the MABE office no later than close of business on **Friday, April 21, 2023**.

Each nomination must consist of the following:

1. The award submission form. The nominee's name may appear **only on this form**.
2. A separate page(s) addressing Part 1 and Part II as detailed on the submission form.
